BACKGROUND

The Directors and officers of the District must be citizens of the United States. All Directors shall be residents of the District and shall be registered voters at the time of their election and/or appointment of office and during their term of office. Directors are required to complete ethics and sexual harassment training every two years and within a year of taking office.

The Board of Directors sets policy and procedure for the District. The Districts General Manager and staff shall provide written and oral communications necessary for the Board to develop such policy and procedure. The Board in turn will provide direction to the General Manager regarding District policy and procedure as set forth and how that policy and procedure is to interface with effective and efficient operation of the District. The General Manager is charged with the operation and/or administration of the District within the guidelines of established Board policy and procedure. The Board of Directors shall not attempt to manage or micro-manage District operations. The Board of Directors shall not attempt to direct staff members except by their direction to the General Manager.

APPLICANT QUESTIONS:

- 1. Rio Alto Water District is a Special District, governed by California Water Code and subject to the Brown Act and Conflict of Interest Code. All Directors of the District are required to file Conflict of Interest Form 700's annually and upon assuming office and leaving office. These forms are filed with the Tehama County Elections Department. Do you have any problem with filing a Form 700?
- 2. Are you a resident of Lake California and a registered voter?
- 3. Acceptance of the position of Director for Rio Alto Water District would require forfeiture of any incompatible office held, such as a Directorship or a decision making committee membership of the Property Owner's Association. Are you willing to forfeit any incompatible office to assume the position of Director of the Rio Alto Water District?
