

**Rio Alto Water District Billing Schedule, Rates and Connection Fees**

**Metered customers are billed as follows:**

<b>Billing Period</b>	<b>Billing Date</b>
January and February	First week of March
March and April	First week of May
May and June	First week of July
July and August	First week of September
September and October	First week of November
November and December	First week of January

Customers are allowed minimum water consumption per billing cycle, as described in the table below. Minimum bills occur whether the service is used or not.

All consumption above the minimum is billed per 100 cubic feet.
